### University of Primorska

PhD Summer Course: Empirical Applications of Economic Organization and Institutions in Agri-Food Value Chains 22–26 August 2014
University of Primorska, Faculty of Management Koper, Slovenia

The course has two main objectives. First, to familiarize participants with the main concepts of New Institutional Economics and specifically Transaction Cost Economics that are relevant for the study of economic organization and coordination problems. Second, the course focuses on empirical applications of this theoretical background in agri-food value chains.

#### Learning Outcomes:

- Recognize the function of and distinction among organizational arrangements
- Apply the transaction cost theory to analyze the choice and structure of contracts and organizational forms
- Evaluate empirically the determinants of alternative organizational arrangements
- Apply the above skills in problems related to agri-food value chains
