### Activities/outputs are maintained

i.e. the project application will be used to promote Mobility Actions (especially, those focused on international professional work placements) not only under Erasmus +, but also other programs such us Erasmus for young entrepreneurs.

### Partner's contributions

The website will remain active for at least 5 years.

It will support the implementation of mobility projects under Erasmus + Program, aligned with the Chamber of Commerce strategy as well as by supporting educational institutions or other type of organisations acting as sending institutions.

Also it will support our participation Erasmus for Young Entrepreneurs projects and it will contribute to other entities can participate.

It will support Chambers' Network in their access to mobility projects (there are many queries)

WELCOME & CO online IT tool will remain available for future projects' proposals.

The survey is transferable to other regions and Chambers.

The SMEs report contributions will be very useful for implementing projects' proposals submitted.

### **Unioncamere del Veneto- Eurosportello**

Maintain a constant dialogue with the local initiatives on multiple level:

- **Local**: strengthening the existing relations with local stakeholders, such as CPV, Verona Innovazione, Eurocultura, as well as with Regional Institutions such as Veneto Sviluppo, to build and enforce a regional network of institutions cooperating on mobility-related projects;
- **European**: connecting WELCOME & CO with existing mobility programmes such as Erasmus for Young Entrepreneurs or E.R.M.E.S.
- Ca' Foscari University and IUAV.



### **Cornwall College**

Traditionally, Cornwall College has not actively participated in international professional work placements. Welcome & Co has increased access to and knowledge of international placements and therefore is more likely to participate in the future. This includes direct access to active receiving institutions who already have significant experience.

### **University of Primorska**

The project should be developed in the last moments of its duration towards a sustainable self-contained organism. It should not be any longer dependent on an intermediary organization, but rather it should be an open-source free platform with one straight goal: allow institutions with little resources (schools) or know-how to be equal partners in the pool of mobility projects and actions.

When the project will bow to the market-economy model it will lose its appeal.

It is why the IT tool should be designed in detail to become self-sustainable.

The University of Primorska is prepared to continue a "soft" administration of the project database after the ending of the project, but is strongly inclined towards a free platform, which will be able to work by itself in all the mobility actions, which link SMEs and Educational institutions.

### **Berlink ETN GmhH**

BERLINK applied last year to be a recognized intermediary organization within the Erasmus for young entrepreneurs Programme. The proposal was unfortunately not successful. We will however for sure promote the Welcome & Co developed activities with partner institutions working on EU funded programs for international work placements, different from Erasmus Plus.

Among those we could for sure list the transnational initiatives for mobility experiences promoted for young unemployed people through the European Social Funds and managed by Regional Authorities.



### Activities/outputs are developed

i.e. needs of SMEs (Small and Medium-Size Enterprises) are assessed, will be used to develop materials and strategies within partners institutions; how will it support employability and/or entrepreneurship strategies.

Welcome & Co approach will become part of the internationalization strategy of the Chamber of Commerce of Cantabria.

### **Unioncamere del Veneto- Eurosportello**

The Welcome&Co platform will be used as a database: on one side the SMEs and institutions already registered will be regarded as potential partners in future project related to mobility, on the other UCV will exploit its basin of SMEs and local stakeholder to support the platform.

Monitoring the needs of the registered SMEs, we will address them to the institution who might better suit their needs: i.e., if a company prefers to maintain contact with a specific Country, we will facilitate a fast-track connection with the partner institution of that country. When it is possible.

Connect the results, i.e.: the database with new project proposals, such as those already implemented under the Erasmus + programmes – UCV will thus ensure the quality of VET mobility contributing to its validation.

### **Cornwall College**

Cornwall College has extensive experience working with SMEs within the western peninsula of England (Cornwall). There are over 25,000 VAT registered businesses, the majority of which are SMEs. The College has a clear understanding of employers needs and works actively with over 10,000 SMEs in Cornwall.

Cornwall College delivers 3,000 apprenticeship programmes annually, has an extensive graduate placement (Higher Education) work placement programme and actively places learners studying further education programmes with employers.

Enterprise and employability are embedded in all of our learning programmes. We have developed a number of case studies which will be available via Welcome & Co and embedded in the website for use beyond the project.



### **University of Primorska**

In view of the self-sustainability of the project, each project partner should begin a period of "education" of both parties, SMEs and Educational institutions. It should be clear to both that each mobility partnership should be undertaken with a dialogue between both partners and not just for the financial aspect of the project.

It is thus necessary to develop a "culture" of communication between the needs and offers of both parties, practice and theory.

It is why the intermediary institutions should try to explain (directly or indirectly) the advantages of the database to both partners, making it clear that the statement of preferences and needs is crucial for a good match.

### **Berlink ETN GmhH**

The analysis carried out though Welcome&Co has been used to identify the needs of our partner host companies and to define a strategy to consolidate the relationship with our partners.

We will organize annual informal meetings with the host companies, as occasion for networking and opportunity to discuss new cooperation initiatives, also enhancing the establishment of links between the companies.



### Activities/outputs can be disseminated

i.e. the website will be a useful tool for partners to maintain or to develop their strategy regarding mobility in Europe, it could be used as a platform to collect information on all mobility programs in an SMEs' friendly way

- ETDT: European Training and Development Federation- an umbrella organisation linking 12 national associations, bringing together around 146,000 members;
